

City of Gaziantep: Gaziantep (Turkish pronunciation: [ga:ˈziantep]), historically Aintab and still informally called Antep (pronounced [ˈantep]), is a major city in south-central Turkey. It is the capital of the Gaziantep Province, in the westernmost part of Turkey's Southeastern Anatolia Region and partially in the Mediterranean Region. It is located approximately 185 km (115 mi) east of Adana and 97 km (60 mi) north of Aleppo, Syria and situated on the Sajur River. The city is thought to be located on the site of ancient Antiochia ad Taurum and is near ancient Zeugma.


Gaziantep Chamber of Industry (GSO): In the late 80s, a quite considerable manufacturing sector was established in the Unaldi area, Nizip Street, the Small Industrial Site, the Sample Industrial Site, and the Second Industrial Area. Therefore the issues regarding transportation, infrastructure, energy, and the environment were beginning to separate from the usual trading issues. With the new problems, the needs and expectations of industrialists were different. The establishment serving back then called 'Gaziantep Chamber of Industry and Commerce' was re-established as 'Gaziantep Chamber of Industry' by industrialists' huge efforts in 1989 with the Law of Union of Chambers and Commodity Exchanges No. 5174. As it is stated in the law, the GCI (GSO) is founded as a public corporation with a legal entity in order to fulfill the common needs of the members; facilitate professional activities; help to improve the professions in accordance with the general interests; protect and dominate the solidarity, discipline and morality of relationships for both in between members and public; perform the tasks stated in the law regarding the services and duties given to the Chamber.

Gaziantep Chamber of Industry has accomplished its corporate development by aiming to improve its service quality continuously since it was established and with the experience it had, the GCI completed many projects to benefit * GSO &

Southeast Anatolian Exporters' Associations (GAIB): The Exporters Associations have been established with the aim of contributing to the improvement of exports, carrying out export related transactions on behalf of their members and coordinating business activities and relations of exporters, finding solutions to their problems and providing guidance. Exporters engaged in different sectors join exporters' associations depending on the type of their business operations. Each exporter's association has a board of directors, whose members are elected by the exporters. Southeast Anatolian Exporters Assc. were found in 1984 for the purpose of increasing export in Gaziantep and in Southeast Anatolia Region of Turkey. There are four exporters association within the General Secretariat of the Southeast Anatolian Exporters Associations, which is abbreviated to GAIB. GAIB has its headquarters in Gaziantep and renders its services to its active members via its liaison offices in Diyarbakır, Kahramanmaraş, Malatya, Mardin, Şanlıurfa, Adıyaman, Kilis, Cizre/Şırnak and Gaziantep Free Zone in the region.
